DRAMA CLASSES IN BELFAST AND ANTRIM

COURSE CONTENT

Our drama classes involve mime, dance, improvisation, scripted performance and the study of leading practitioners in the industry. We encourage our students to work collaboratively learning key performance techniques in a mutually encouraging environment. We use performing arts vocabulary, equipping our students to become self-evaluating. From the age of 4, we start to build the child's ability to express themselves creatively and explore age relevant issues using recognised dramatic forms. We have a range of abilities in our classes and seek to develop the potential of every child. We structure our lessons so that there is a performance aspect during every class to develop audience awareness. Our staff are all trained teachers who work in educational establishments and understand the pedagogy required for teaching Drama. We are a self-evaluating organisation, always striving to better the pupil experience and professionally deliver recognised qualifications in Performing Arts.

NB: When making an online bank transfer it is vital that you use your child's name as the bank reference so that we know which pupil the payment is for.

Some financial full / half scholarships are available for students financially challenged. A scholarship application can be obtained from Rachel Robinson and needs to be returned to info@youthlyric.co.uk These are then passed to the Artistic Director and Head of Curriculum for consideration and dealt with in the strictest confidence. All successful applicants will be expected to pay £5 annual insurance. Evidence will help to support the application. There is a sibling discount on fees of £5 per child.

ENTRY REQUIREMENTS

There are no formal entry requirements for Youth Lyric. Youth Lyric does not operate auditions in order to join. We welcome children and young people of all abilities. There is wheelchair access at every centre. Everyone is entitled to a Taster session when they can decide whether participation in Youth Lyric is for them. Many students come to Youth Lyric classes with experience of school plays and work in professional productions. However, many of our pupils join Youth Lyric with no experience, just a healthy interest in the subject area. This is equally acceptable and valuable.

ANNUAL PRODUCTIONS

Each year Youth Lyric Belfast or Youth Lyric Antrim put on a large production which all students are invited to audition for. Our previous performances are listed on our website [Youth Lyric Productions - Youth Lyric Belfast](#)

THEATRE TRIPS

Youth Lyric believes that all P7 students and above should be given the opportunity to see live theatre and we endeavour to make it affordable to all. Information about these trips will be shared through email by our administrators. Local theatre trips to the Grand Opera House may also be included with a pre-show meal at Scalini and are priced approximately £60.00.

FESTIVALS

Festival takes place each year in a venue in Belfast. This is a time for us to celebrate the work of our young people and for parents to see the skills they are developing in class.

It is a wonderful occasion, where pupils from all our classes prepare performance pieces and are adjudicated by a special Youth Lyric guest. We use this opportunity

to make special awards and have accumulated many cups and trophies over the years, which we take pride in bestowing on our young people.

Tea, coffee and traybakes are available, the cost of the festival ticket is £10 per adult, children are free. Tickets include refreshments and all Youth Lyric students can attend for free.

TRINITY EXAMINATIONS

Trinity College London, the international examinations board offers accredited qualifications in English language and the Performing and Creative Arts.

Over the last 10 years Youth Lyric theatre school has successfully entered between 150-200 pupils for Trinity exams each year achieving a 100% annual pass rate in Grades 1-8.

Trinity Examinations may be taken by individuals, by pairs or by groups of three or more. All examinations offer candidates opportunities to demonstrate performance skills appropriate to their individual interests and aspirations. These examinations are not compulsory and pupils opt in if they wish to avail of this opportunity. Pupils will be assessed in class by their teacher and entered for the appropriate grade. Grades 6-8 in Acting and Speaking are recognised by UCAS and qualify for tariff points as indicated below:

This examination will take place in June 2024, when a visiting examiner will come to Stranmillis College to assess the pupils. Those entered, will be prepared by Youth Lyric staff with additional rehearsals organised, if required, nearer the time.

COST OF TRINITY EXAMINATION – May be subject to change

Youth Lyric is a Registered Charity and our mission is to reinvest profits back into the organisations to ensure its longevity. To offer formal examinations and operate as an examination centre, we must cover the costs to the organisation. The costs of the examination to the parent are outlined below and we would emphasise that this charge covers the requirements by Trinity and any administrative costs required to host the examination.

The tutors will inform pupils and parents on the grade they are being entered for. The grade chosen will be reflective of your child's skills.

As children are usually entered in groups of 3-6, this means that it is vital that your child attends all classes and rehearsals. Failure to do so will jeopardise the success of the other children in the group. To that end, we will furnish you with the dates of Trinity examination days and dates well in advance. As these are stipulated by Trinity, we do not have the ability to change them. We would therefore ask that you keep these dates clear in your diary and avoid booking other appointments during this time. We understand that during the month of May and June, our pupils may have music and dance examinations whilst they are in the run up to Trinity. We would kindly ask you to ensure that your child has the time to prepare fully for Trinity before they commit to it. This is to reduce pressure on the other children in their group. If your child fails to attend regular classes and rehearsals in preparation for Trinity and others in the group are being disadvantaged by this, we may have to remove them from their group. Unfortunately, we will not be in a position to refund the examination fee as this will have already been paid to Trinity.

If you would like to enter your child for their Trinity examination, payment will be required a minimum of 6 weeks before the date of the exam.

SOCIAL MEDIA

Social networking sites (such as, but not exclusively, Facebook, YouTube, Twitter etc.) are a useful way for keeping in touch with friends, family and Youth Lyric pupils and are also a great way to exchange information. However, pupils, relatives and staff must not forget that what they post on social networking sites may be seen across these networks and are reminded that they must not bring Youth Lyric into disrepute or cause any distress to any other member. CODE OF CONDUCT FOR PUPILS

A Code of Conduct (or a group agreement) for children outlines appropriate and inappropriate behaviours (including language), which should be valid for the duration of a group's involvement with an organisation (e.g. on an annual basis or for a one-off workshop). It is good practice to involve children in developing a code of behaviour that is specific to their activity. The following key principles should apply:

DO:

- ✓ Wear clothing that is appropriate to the activity including Youth Lyric top.
- ✓ Include and encourage the participation of other group members.
- ✓ Listen to others.
- ✓ Ask questions if you are unsure about something.
- ✓ Respect other children and adults at all times.
- ✓ Use allocated toilet and changing facilities where available.
- ✓ Tell a leader straight away if you (or another child) feel uncomfortable or frightened by the actions or words of another adult or child.
- ✓ Say 'no' if you feel uncomfortable at any time (e.g. during an activity).
- ✓ Follow safety guidelines and instructions for an activity and adhere to social distancing guidelines

DON'T:

- ✓ Shout, swear or use inappropriate language.
- ✓ Make fun of others.
- ✓ Exclude or make assumptions about others.
- ✓ Fight/push/pull/hit/nip/bite – even in fun.
- ✓ Tell jokes or stories that are rude or may offend or hurt others.
- ✓ Run in corridor areas/backstage.
- ✓ Keep bullying or inappropriate behaviour a secret.
- ✓ Promise to keep secrets.
- ✓ Use mobile telephones during activities (including breaks) or take photo or record or take a video during a break, at rehearsal or after class, unless specifically requested to do so by the tutor.

CODE OF CONDUCT FOR GROUPS:

Safety is paramount while participating in an activity.

If it is necessary to review and amend the content of the code of behaviour at any time, Youth Lyric will advise groups and will regularly revisit and apply to amended

group codes of behaviour. Consideration will be given to each activity Youth Lyric embarks on. Youth Lyric should also consider how best to include a child who has been known to pose a risk to others. In such instances, Youth Lyric will undertake an assessment and ensure it consults with the child as well as those who know the child well (e.g. parents/guardians, teachers, social workers). Youth Lyric works with children and adults (aged 18 and over) and has procedures and guidance to protect all participants. All participants are aware of, and adhere to, the code of behaviour. If supervisory responsibilities are to be given to a participant, they should be subject to an Access NI check.

Participants aged 18 and over should be made aware of issues such as appropriate behaviour (including language and topics of conversation) and being a good role model to the younger participants within the group. Daytrips and residential activities should be carefully planned using Risk Assessments, with particular attention given to accommodation needs and supervision of group members.

SNACKS

We appreciate that some of the children attending Youth Lyric may wish to bring snacks and drinks. All our venues have stated that this is not allowed and only water in a sealed container is permitted.

WHAT TO WEAR

We are proud to have our own Youth Lyric branded clothing. Your child can have up to four initials embroidered on their hoodie, e.g. EMMA or E.L. (initials of their name and surname). Payment for the hoodie or t shirt will be required before your order can be processed. Please use the same bank sort code and account number. You will need to confirm the age/size/initials by emailing the Administrator.

The cost of the junior hoodie (N-P7) is £22 and the senior hoodie (Yr 8-Yr 14) is £27. The Youth Lyric branded t-shirts are also available at a cost of £12-£14 depending on size/type required. We would kindly ask that all students purchase one of these as they will require this for classes, auditions and both Festival and Trinity examinations and when we are representing the organisation on trips. It also provides a warm layer when working in class each week and on stage. Pupils are requested to wear black / dark coloured leggings or trousers for classes, Festival and Trinity with their Youth Lyric t-shirt or hoodie.

SANCTIONS

A breach of procedures and guidelines must be taken seriously and staff, children, parents/guardians and other service users should note the following:

Sanctions for children who breach the Code of Conduct may include taking time out from participating in an activity or temporary suspension from the organisation.

Contacting the child's parents/guardians will also be considered in some instances and in the most extreme cases, it may be necessary to consider permanent suspension.

Early intervention and dialogue with children should minimise the need to apply more serious sanctions. Staff members are trained to have a positive behavioural approach in all situations, endeavouring to support the pupil who is in breach of conduct whilst minimising the impact on other pupils.

PARENTAL CONSENT & SHARING OF INFORMATION

Youth Lyric needs to gain information about children in its care and parental consent in relation to medical/dietary requirements, activities, day trips and emergency situations. Consent to share information must be given by those with Parental Responsibility.

Records using the Parental Consent & Student Information form should be maintained and updated regularly for the following information:

- ✓ Name of the child (as it appears on the child's passport),
- ✓ Name, addresses and contact numbers for children and their parents/guardians;
- ✓ information about health issues/medication/dietary requirements/allergies & intolerances will be collated in the parental consent and student information form issued when the child joins YL;
- ✓ parental consent for all activities/emergency situations (including emergency contact numbers;
- ✓ special educational needs;
- ✓ permission to photograph and film the child;
- ✓ permission to share parent's email address with casting agencies when they contact us, as appropriate;
- ✓ an additional consent form will be issued to parents/guardians for any specialist activities over and above the normal ones (e.g. a residential weekend, a visit to another dance school or a theatre and/or chaperoning a child for an audition).

Youth Lyric makes parents/guardians aware of their commitment to ensuring the safety and welfare of all children and the requirement to know of any medical, dietary or behavioural conditions in relation to a child. The need to provide Youth Lyric with all information (even that which is not considered significant) should be

clearly communicated, in order to ensure the needs of the child can be met and to minimise placing a child and/or others at risk of harm.

Youth Lyric will make every effort to communicate to all involved, regardless of language and communication needs. The main means of communication will be **via email or text**. Regular emails will be sent out to parents. Youth Lyric's commitment to inclusiveness, pointing out that a condition is very unlikely to preclude a child from being involved and that efforts will be made to provide appropriate methods of support. We work closely with the child, parents/guardians and support organisations (if appropriate) to maximise a child's participation.

Youth Lyric will provide as much information about regular activities as possible (e.g. wearing make-up and costume) and specify any requirements that parents/guardians, and children, should be aware of (e.g. to wear loose clothing when engaging in dance or free movement activities, for example). Guidelines should also be given, for example, with regards to inappropriate clothing. Children will be requested to wear their Youth Lyric branded hoodie, t-shirt and black/dark coloured trousers/leggings for classes and events including theatre trips, for Festival and Trinity examinations.

CHILD PROTECTION

Youth Lyric has an up to date Child Protection policy which has been ratified by the Board of Trustees. Parents can receive a copy on request from the Administrator. It is also available on our website www.youthlyric.co.uk
